## SYNOD COUNCIL

#### SYNOD VICE PRESIDENT

- Layperson & Voting Member of a Synod Congregation
- 4 Year Term
- May Be Re-Elected
- Elected by Synod Assembly
- Chairs Synod Council Responsible for planning and leading meetings, ensuring meetings are conducted effectively and business is well managed
- Serves on the Executive Committee of the Council
- · Advises & Supports the Bishop
- Serves as Synod Assembly Co-Chair with the Bishop
- Participates in Vice Presidential Networks (Regional and Churchwide)
- Assist with Synod mission & vision planning & development processes

#### SYNOD SECRETARY

- Voting Member of a Nebraska Synod Congregation
- 4 Year Term
- May Be Re-Elected
- Elected by Synod Assembly

- Keeps meeting minutes and is responsible for the communication and coordination of their distribution
- Serves on the Executive Committee of the Council
- Authorized and empowered, in the name of the synod, to attest all instruments which require the same, and which are signed and sealed by the bishop
- In consultation with the bishop, classify and arrange all important papers and documents and deposit them in the archives of this synod

## SYNOD TREASURER

- Voting Member of a Nebraska Synod Congregation
- 4 Year Term
- May Be Re-Elected
- Elected by Synod Assembly

- Serves on the Executive Committee of the Council
- · Manages the monies and accounts of this synod
- Invests funds upon the authorization of the Synod Council
- Maintains and regularly communication with congregations regarding their accounts
- Provides full and detailed reports of receipts and disbursements for meeting minutes

#### SYNOD COUNCIL MEMBER

- Voting Member of a Nebraska Synod Congregation
- 6 Year Term
- May Be Re-Elected
- Elected by Synod Assembly

- Participates in quarterly Synod Council Meetings
- Participates in Annual Synod Assembly
- Functions of the Synod Council Include:
  - Carry out resolutions of the Synod Assembly
  - Recommends budgets to the Synod Assembly
  - Provides annual reviews of rostered ministers to the Synod Assembly
  - $\circ\hspace{0.1cm}$  Performs other functions set forth in the bylaws of the Synod

## CONSULTATION COMMITTEE

- Voting Member of a No Consecutive Re-Nebraska Synod Congregation
- 6 Year Term
- Election

- Serves when there is a disagreement between or among congregations on a substantive issue that cannot be resolved by the parties involved
- Works together as a committee to undertake efforts for find an appropriate solution

- Voting Member of a No Consecutive Re-Nebraska Synod Congregation
  - Election
  - Elected by Synod Assembly
- Members are available to work with the Bishop/Synod Council when there are issues involving disciplinary proceedings

# **AUDIT COMMITTEE**

- Voting Member of a Nebraska Synod Congregation
- 3 Year Term

- May Be Re-Elected
- Elected by Synod Council
- Responsible for assisting the Synod Council in fulfilling its general oversight of the synod's accounting, financial reporting, internal control systems, and external audit processes as provided in †\$15.31.

## **BUDGET & FINANCE COMMITTEE**

- Voting Member of a Nebraska Synod Congregation
- 4 Year Term
- May Be Re-Elected
- Elected by Synod Council
- Prepares and presents a comprehensive budget to the Synod Council, in consultation with the Bishop, for its consideration and presentation to the Synod Assembly.
- In the preparation of the budget the committee consults with committee and task force chairpersons as well as the chief executive officers of related institutions
- · Reviews the finances of the synod during the fiscal year as needed or as requested by the bishop or Synod Council.
