Nebraska had nine traveled for the convention, which included the election of the 2023-2026 Executive Board. She was able to share the Gathering experience with her daughter. The NSWO Convention was held in the beginning of October. She shared a concern brought forth from a board member that a pastor is telling their ladies not to be involved in W/ELCA. How do we meet them where they are and get them back?
